



**AN ACT TO AMEND § 3219(a) OF ARTICLE 2,
CHAPTER 3 OF TITLE 16, GUAM CODE ANNOTATED,
RELATIVE TO UPDATING THE CURRENT
STANDARDS ON TIRE SAFETY.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings.** *I Liheslaturan Guåhan* (the Guam
3 Legislature) finds that Public Law 29-120, which established restrictions on the
4 sale of old tires in 2008, should be updated to reflect the standards established by
5 the U.S. Department of Transportation and to better meet the requirements of

6 consumers, while maintaining adherence to a reasonable standard of safety for the
7 use of these tires on public roads.

8 **Section 2.** § 3219(a) of Article 2, Chapter 3 of Title 16, Guam Code
9 Annotated, is *amended* to read as follows:

10 “(a) The sale of tires older than ten (10) years, for use on vehicles
11 operated on the highways and roadways of Guam, is prohibited; *except* for
12 Trucks & Buses Radial (TBR) tires, which *shall not* be older than six (6)
13 years when for sale.”


