



**AN ACT TO ADOPT THE RULES AND REGULATIONS  
OF THE PEACE OFFICER STANDARDS AND  
TRAINING COMMISSION CONCERNING  
CERTIFICATION OF PEACE OFFICERS AND  
STANDARDS FOR EMPLOYING AGENCIES AND  
TRAINING INSTITUTIONS, TO BE CODIFIED UNDER  
A NEW CHAPTER 3 OF TITLE 27 - GUAM  
ADMINISTRATIVE RULES AND REGULATIONS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds  
3 that the Rules and Regulations, GUAM P.O.S.T. (PEACE OFFICER

1 STANDARDS AND TRAINING) COMMISSION ADMINISTRATIVE RULES,  
2 were duly promulgated by the Peace Officer Standards and Training Commission,  
3 both pursuant to § 51102(h)(2) of Chapter 51, Title 17, Guam Code Annotated  
4 (Peace Officer Standards and Training Commission), and pursuant to Article 3 of  
5 Chapter 9, Title 5, Guam Code Annotated (Rule-Making Procedures).

6 *I Liheslaturan Guåhan* finds that there are a number of crimes that impact  
7 the safety of our island community and there should be uniform minimum  
8 standards for peace officers on Guam with respect to education, training, and  
9 physical fitness.

10 *I Liheslaturan Guåhan* further finds that having this information readily  
11 available in a central database system and at the Guam Community College (GCC)  
12 ensures that all peace officers have access to the standards in order to readily  
13 prepare for the Physical Fitness Qualification Test and all other required standards  
14 of performance, to include competencies required to appropriately interact with  
15 people with disabilities and people with mental health challenges. Additionally,  
16 this allows for public participation and provides them with a sense of security that  
17 all peace officers abide by a minimum standard.

18 It is, therefore, the intent of *I Liheslaturan Guåhan* to adopt the Rules and  
19 Regulations aforesaid, appended to this Act as “EXHIBIT A, as Amended”.

20 **Section 2. Adoption of Rules.** The Rules and Regulations, entitled  
21 GUAM P.O.S.T. (PEACE OFFICER STANDARDS AND TRAINING)  
22 COMMISSION ADMINISTRATIVE RULES, and attached hereto as “EXHIBIT  
23 A, as Amended” are hereby adopted by *I Mina’Trentai Dos Na Liheslaturan*  
24 *Guåhan* and shall be codified under a new Chapter 3 of Title 27, Guam  
25 Administrative Rules and Regulations.

26 **Section 3. Amendment of Rules.** The Peace Officer Standards and  
27 Training Commission shall, pursuant to Article 3 of Chapter 9, Title 5, Guam Code

1 Annotated, review and amend, as may be necessary, the Rules and Regulations  
2 adopted pursuant to Section 2 of this Act.

3 **Section 4. Severability.** If any provision of this Act or its application to  
4 any person or circumstance is found to be invalid or contrary to law, such  
5 invalidity *shall not* affect other provisions or applications of this Act which can be  
6 given effect without the invalid provisions or application, and to this end the  
7 provisions of this Act are severable.

8 **Section 5. Effective Date.** This Act *shall* become effective upon  
9 enactment.


