AN ACT TO APPROPRIATE FUNDS FROM FISCAL YEAR 2014 FUND BALANCE **OF** THE **TOURIST** ATTRACTION FUND TO THE **GUAM** POLICE DEPARTMENT **FOR OVERTIME** COMPENSATION.

#### BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that the sum of Four Million Dollars (\$4,000,000) from the unappropriated,
- 4 unallocated fund balance of the Fiscal Year 2014 Tourist Attraction Fund (TAF) is
- 5 available for appropriation.

- Section 2. Appropriation. Notwithstanding § 30107 of Chapter 30, Title 11 GCA, the sum of One Million Two Hundred One Thousand Eleven Dollars (\$1,201,011) is hereby appropriated from the unappropriated, unallocated fund
- 4 balance of the Fiscal Year 2014 Tourist Attraction Fund to the Guam Police
- 5 Department for overtime compensation accrued for Fiscal Year 2015.
- 6 Notwithstanding the general provisions of § 30107.1 of Chapter 30, Title 11 GCA,
- 7 this appropriation is *not* subject to transfer or use for any other purpose.
