AN ACT TO GRANT A CERTIFICATE OF TITLE FOR LOT NO. 5138-2-R3 NEW-1-1, *IPAO-TUMON*, MUNICIPALITY OF *DEDEDO*, IN THE NAME OF THE CHAMORRO LAND TRUST COMMISSION; AND TO AUTHORIZE THE COMMERCIAL LEASING OF SAID LOT.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that Lot No. 5138-2-R3NEW-1-1, *Ipao-Tumon*, municipality of *Dededo*, has been
- 4 in neglect, unclean, unkempt and abandoned for over twenty (20) years. I
- 5 Liheslaturan Guåhan further recognizes that Lot No. 5138-2-R3 NEW-1-1, Ipao-

- 1 Tumon, municipality of Dededo, is not suitable for Chamorro Land Trust
- 2 Commission agricultural or residential development, but would be more efficiently
- 3 used for "commercial activity" because of its prime frontage location in a
- 4 predominantly commercial area.
- 5 I Liheslaturan Guåhan further finds that Lot 5138-2-R3 NEW-1-1, Ipao-
- 6 Tumon, municipality of Dededo, came under the jurisdiction of the Chamorro Land
- 7 Trust Commission by operation of law, an expired or cancelled lease and by § 75104
- 8 (a) and § 75105 (a) of Chapter 75, Title 21, Guam Code Annotated.
- 9 I Liheslaturan Guåhan intends to grant a certificate of title for Lot No. 5138-
- 10 2-R3 NEW-1-1, *Ipao-Tumon*, municipality of *Dededo*, to the Chamorro Land Trust
- 11 Commission. This lot is intended for commercial leasing to be managed by the Guam
- 12 Economic Development Authority as a more productive and profitable asset for the
- 13 beneficiaries of the Trust.
- 14 Section 2. Issuance of Certificate of Title. The Department of Land
- 15 Management is hereby directed to issue a certificate of title for Lot No. 5138-2-R3
- 16 NEW-1-1, *Ipao-Tumon*, municipality of *Dededo*, containing an area of 2,868+
- square meters as shown on Department of Land Management Map No. 314-FY 89,
- attached as Exhibit A, to the Chamorro Land Trust Commission. This lot is to be
- 19 added to the Chamorro Land Trust Commission lands inventory for commercial
- 20 leasing.
- Section 3. Exemption. § 2107 of Chapter 2, Title 2, Guam Code Annotated,
- 22 and the Standing Rules of I Mina'Trentai Tres Na Liheslaturan Guåhan relative to
- 23 the appraisals of land shall not apply to this Act.
- Section 4. Effective Date. This Act *shall* be effective upon enactment.
- Section 5. Severability. If any provision of this law or its application to
- any person or circumstance is found to be invalid or contrary to law, such invalidity
- 27 shall not affect other provisions or applications of this law, which can be given effect

- 1 without the invalid provisions or application and to this end the provisions of this
- 2 law are severable.
