

**AN ACT TO ADD A NEW SUBSECTION (y) TO § 87104
OF CHAPTER 87, TITLE 5, GUAM CODE ANNOTATED,
RELATIVE TO ESTABLISHING INTERIM ADMISSION,
EVENT, AND MEMBERSHIP FEES FOR THE GUAM
MUSEUM.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new Subsection (y) is *added* to § 87104 of Chapter 87, Title 5,
3 Guam Code Annotated, to read as follows:

4 “(y) to establish interim admission, event, and membership fees for
5 the Guam Museum, without prior legislative approval and without compliance

1 with the Administrative Adjudication Law; provided, that the interim fees
2 *shall* sunset December 31, 2017.”
