AN ACT TO AMEND § 3207 OF CHAPTER 3, ARTICLE 2, TITLE 11, GUAM CODE ANNOTATED, RELATIVE TO ALCOHOLIC BEVERAGE CONTROL LICENSES.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that § 3207 of Chapter 3, Article 2, Title 11, Guam Code Annotated, provides for the application and issuance of licenses, classes, and fees for various alcoholic beverages. While § 3207 allows separate on-premises and off-premises licenses for beer-only establishments and general sale establishments, it only provides for a Class 4 on-premises wine-only license, a wine bar, and it does not provide for a Class 5

1 off-premises wine-only license, a dedicated wine shop. I Liheslaturan Guåhan finds that many other jurisdictions have wine shops, which may contribute to the culture 2 and the economic viability of an area. 3 It is, therefore, the intent of the I Liheslaturan Guåhan to add a Class 5 wine-4 only license with a fee of Four Hundred Dollars (\$400) per year to the list of various 5 6 alcoholic beverage licenses which may be issued. 7 Section 2. § 3207 of Chapter 3, Article 2, Title 11, Guam Code Annotated, 8 is hereby *amended* to read: 9 Licenses: Classes and Fees. **"§ 3207.** 10 The Board is authorized to issue the following classes and kinds of licenses at 11 the following fees: 12 Class 1.
