



**AN ACT TO *AMEND* § 3207 OF CHAPTER 3, ARTICLE 2,
TITLE 11, GUAM CODE ANNOTATED, RELATIVE TO
ALCOHOLIC BEVERAGE CONTROL LICENSES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that § 3207 of Chapter 3, Article 2, Title 11, Guam Code Annotated, provides for
4 the application and issuance of licenses, classes, and fees for various alcoholic
5 beverages. While § 3207 allows separate on-premises and off-premises licenses for
6 beer-only establishments and general sale establishments, it only provides for a Class
7 4 on-premises wine-only license, a wine bar, and it does not provide for a Class 5

1 off-premises wine-only license, a dedicated wine shop. *I Liheslaturan Guåhan* finds
2 that many other jurisdictions have wine shops, which may contribute to the culture
3 and the economic viability of an area.

4 It is, therefore, the intent of the *I Liheslaturan Guåhan* to add a Class 5 wine-
5 only license with a fee of Four Hundred Dollars (\$400) per year to the list of various
6 alcoholic beverage licenses which may be issued.

7 **Section 2.** § 3207 of Chapter 3, Article 2, Title 11, Guam Code Annotated,
8 is hereby *amended* to read:

9 **“§ 3207. Licenses: Classes and Fees.**

10 The Board is authorized to issue the following classes and kinds of licenses at
11 the following fees:
