
CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LÅHEN GUÅHAN

AN ACT TO REPEAL AND RE-ENACT § 51302 OF ARTICLE 3, CHAPTER 51, TITLE 10, GUAM CODE ANNOTATED, RELATIVE TO ESTABLISHING THE RECYCLING REVOLVING FUND AS A SEPARATE ACCOUNT NOT TO BE COMMINGLED WITH THE GENERAL FUND AND MANDATING THAT REVENUE GENERATED FROM RECYCLING FEES COLLECTED PURSUANT TO ARTICLE 3, CHAPTER 51, TITLE 10, GUAM CODE ANNOTATED, BE EXPENDED EXCLUSIVELY FOR PURPOSES AUTHORIZED IN THE SAME.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 51302 of Article 3 of Chapter 51 of Title 10, Guam Code
3 Annotated, is *repealed* and *re-enacted* to read:

1 “§ 51302. **Recycling Revolving Fund.** There is hereby created the
2 Recycling Revolving Fund (Fund), which *shall* be maintained separate and
3 apart from any other funds, including the General Fund of the government of
4 Guam, and independent records and accounts *shall* be maintained thereof.
5 The Recycling Revolving Fund *shall not* be commingled with the General
6 Fund and *shall* be kept in a separate bank account. All revenue generated
7 from recycling fees collected pursuant to this Article, including interest
8 earned, *shall* be deposited into the Recycling Revolving Fund and *shall* be
9 expended exclusively for the purposes authorized in Article 3 of Chapter 51
10 of Title 10, Guam Code Annotated. The funds deposited into the Recycling
11 Revolving Fund *shall not* be subject to the transfer authority of *I*
12 *Maga'låhen Guåhan.*”
