

AN ACT TO *AMEND* § 75121 OF CHAPTER 75, TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO DESIGNATING BLOCK 3, TRACT 1722, MUNICIPALITY OF *MANGILAO*, AS A BIODIVERSITY CONSERVATION EASEMENT FOR THE PURPOSE OF PROVIDING LAND FOR *HATDIN ÅMOT CHAMORRO*.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Mina'Trentai Tres Na*
3 *Liheslaturan Guåhan* finds that *I Mina'Trenta Na Liheslaturan Guåhan* (the 30th
4 Guam Legislature) recognized the need to support the efforts to preserve and

1 perpetuate the practice of the *Chamorro* medicinal healing arts, through the
2 passage and enactment of Public Law 30-32.

3 *I Liheslaturan Guåhan* finds that Block 3, Tract 1722 in the municipality of
4 *Mangilao*, as shown on Land Management Instrument No. 880762, is uniquely
5 suited for the purpose originally identified in Public Law 30-32. More specifically,
6 *Hatdin Ámot Chamorro* will become an invaluable tool for cultural preservation
7 and conservation efforts, housing the many indigenous herbal species of flora used
8 for medicinal purposes.

9 *I Liheslaturan Guåhan* finds that the designation of this parcel as a
10 Biodiversity Conservation Easement for *Hatdin Ámot Chamorro* will protect this
11 land from commercial and residential development. Furthermore, the designation
12 will assure the preservation of Guam's pristine eastern coastline and limestone
13 forest.

14 *I Liheslaturan Guåhan*, therefore, intends to authorize and allow the
15 *Chamorro* Land Trust Commission to designate Block 3, Tract 1722, municipality
16 of *Mangilao*, as a Biodiversity Conservation Easement for the purpose of
17 establishing *Hatdin Ámot Chamorro* and to allow the *Håya Foundation*, which
18 focuses on preserving, perpetuating, and promoting the indigenous practices of
19 traditional healing through medicinal plants, access to said lot in order to
20 transplant, cultivate, and perpetuate native flora used for traditional healing.

21 **Section 2.** § 75121 of Chapter 75, Title 21, Guam Code Annotated, is
22 *amended* to read:

23 **“§ 75121. Establishment of *Hatdin Ámot Chamorro*.**

24 (a) The *Chamorro* Land Trust Commission *shall* designate and
25 make available a parcel of land in the northern part of the island that *shall* be
26 designated as a Biodiversity Conservation Easement for the purpose of

1 transplanting and cultivating herbal plants, and establishing *Hatdin Ámot*
2 *Chamorro*.

3 (b) Block 3, Tract 1722 in the municipality of *Mangilao*, as shown
4 on Land Management Instrument No. 880762 (Exhibit A), *shall* be
5 designated as a Biodiversity Conservation Easement for the purpose of
6 providing land for *Hatdin Ámot Chamorro*.

7 (c) The *Chamorro* Land Trust Commission, in consultation with
8 the *Hâya Foundation* (a non-profit organization dedicated to the
9 preservation of the *Chamorro* healing arts), is hereby directed to establish
10 the criteria, application, and operational procedures of *Hatdin Ámot*
11 *Chamorro*. The procedures *shall* establish the parameters for the usage of
12 the parceled lot and a list of plants to be cultivated. To qualify to use a parcel
13 of *Hatdin Ámot Chamorro*, an applicant must be an individual eligible for
14 residential lease of *Chamorro* Land Trust Commission land, and either:

15 (1) be a member or officer of a non-profit organization
16 registered with the Department of Revenue and Taxation, whose
17 charter includes the advancement of *Chamorro* traditional healing or
18 medicine, or the advancement of *Chamorro* heritage and culture; or

19 (2) be a *Suruhana* or *Suruhanu*, or an apprentice, or a student
20 of traditional *Chamorro* medicines.

21 Preference *shall* be given to an applicant who meets more than one (1)
22 of the qualifications in this Subsection.”

23 **Section 3. Exemption.** § 2107 of Title 2, Guam Code Annotated, and the
24 Standing Rules of *I Mina'Trentai Tres Na Liheslaturan Guåhan* relative to the
25 appraisals of land *shall not* apply to this Act.

26 **Section 4. Severability.** If any of the provisions of this Act or the
27 application thereof to any person or circumstance is held invalid, such invalidity

1 *shall not* affect any other provision or application of this Act that can be given
2 effect without the invalid provision or application, and to this end the provisions of
3 this Act are severable.
