AN ACT TO DESIGNATE LOT NO. 5173-1-R2NEW-4, MUNICIPALITY OF *TAMUNING*, AS A *CHAMORRO* CULTURAL CENTER.

#### BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that from time to time there is a need for legislative intervention to perpetuate the
- 4 Chamorro culture. I Liheslaturan Guåhan also finds that there are only two (2)
- 5 Chamorro cultural centers in the entire world. Gef Pa'go in the village of Inarajan

- serves as the cultural center in southern Guam and Sågan Kotturan Chamoru (SKC)
- 2 serves as the cultural center in central Guam.
- 3 I Liheslaturan Guåhan intends to respect the authority of the existing
- 4 Chamorro Land Trust Commission license agreement dated December 1, 2006 to
- 5 Inadahen I Lina'la' Kotturan Chamoru, Inc., and leaves the administration of said
- 6 license to the *Chamorro* Land Trust Commission.
- 7 Section 2. Property Identified, Designated, and Reserved for a
- 8 Chamorro Cultural Center. Lot No. 5173-1-R2NEW-4 in the municipality of
- 9 Tamuning, containing an area of 34,419± square meters (8.5 acres) as shown on
- Department of Land Management Map No. 004FY2011, and attached as Exhibit C,
- is hereby designated as the site for a *Chamorro* Cultural Center.
- Section 3. Severability. If any provision of this law or its application to
- any person or circumstance is found to be invalid or contrary to law, such invalidity
- shall not affect other provisions or applications of this law that can be given effect
- 15 without the invalid provisions or applications, and to this end the provisions of this
- law are severable.
