1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS,** a group of fifteen (15) representatives from Japan visited
4 Guam for the purpose of showing respect and to offer prayers for those
5 who died during World War II; and

6 **WHEREAS,** those representatives visited the War in the Pacific
7 National Park, Naval Station, *Gaan* Point, the *Manenggon* Memorial Park,
8 and the *Yigo* Memorial in order to better understand the horrors of war and
9 its effects on both the soldiers who fought it and the innocent civilians
10 caught in its wake; and

11 **WHEREAS,** it is hoped that this will continue to be an annual trip,
12 and that the tribute paid by these representatives will shine as an example
13 that will encourage other groups and organizations from Japan to make
14 similar trips; and

15 **WHEREAS,** *U.S. Explore & Study, Inc.* has been instrumental in
16 trying to heal the wounds of World War II, and the tensions over the war
17 between the people of Japan, Guam, and the United States, and has held
18 ceremonies and tributes in the past years with that noble aim; and


19 **WHEREAS,** the *U.S. Explore & Study, Inc.,* along with its President,


