- 2 institution, will observe its Charter Day, marking its founding; and
- WHEREAS, the Territorial College of Guam was founded in 1952, and offered
- 4 limited classes at the old George Washington High School campus in *Mongmong*. The
- 5 College eventually developed from a two (2)-year teacher training institution to a land
- 6 grant university that offers a full range of undergraduate programs and graduate studies,
- 7 and in 1961, they relocated to their present one hundred (100)-acre campus overlooking
- 8 Pago Bay in Mangilao; and
- 9 WHEREAS, the Territorial College of Guam was renamed to the "University of
- 10 Guam" by the Ninth (9th) Guam Legislature after being accredited for the maximum
- 11 period by the Western Association of Schools and Colleges (WASC) in 1968; and
- 12 WHEREAS, the University of Guam's first Charter Day was proclaimed on
- 13 December 17, 1968, by the Honorable Manuel F.L. Guerrero, Governor of Guam,
- 14 through Executive Order 74-09; and
- WHEREAS, the year 2011 marks the Fifty-ninth (59th) year of the founding of
- 16 the University of Guam, and the Forty-third (43rd) Charter Day celebration; and
- 17 WHEREAS, while the University pursues its mission of providing resident
- 18 instruction and research to the people of Guam, it also provides our neighbors
- 19 throughout Micronesia the opportunity to achieve a higher education; and
- 20 WHEREAS, the University of Guam, in its quest to maintain its tradition of
- 21 excellence, continues to contribute to the island's social, cultural, political and
- 22 economic advancement; and
- WHEREAS, the theme for this year's Charter Day: "UOG: Building a Greener
- 24 Tomorrow," reflects the University's goal of developing the professional workforce and
- 25 expertise needed to develop and maintain sustainable communities on Guam, the

- 1 islands of the Western Pacific, and the Asian Pacific Rim nations, through the
- 2 University's vision and mission of research, education and service; and
- WHEREAS, the UOG 2011 Charter Day activities will showcase Guam's
- 4 cultural, social, educational and recreational activities, and the people of Guam are
- 5 invited to visit the Mangilao campus during the week and share in these experiences;
