3        **WHEREAS,** following her graduation from the Academy of Our Lady of  
4   Guam, Lourdes A. (Lou) Leon Guerrero continued her education, earning her  
5   Bachelor of Science Degree in Nursing at California State University, and a Masters

1 Degree in Public Health at the University of California, Los Angeles, prior to  
2 beginning her first career as a health care professional; and

3 **WHEREAS**, Lou Leon Guerrero's service to our island and people began in  
4 1980, when she held the position of Staff Development Coordinator at the Guam  
5 Memorial Hospital (GMH), going on to spend the next fourteen (14) years providing  
6 healthcare services to the community through various positions, both at GMH and at  
7 FHP; and

8 **WHEREAS**, in 1994, Lou Leon Guerrero made the conscientious decision to  
9 do more for the people of Guam and she successfully sought a seat in the 23<sup>rd</sup> Guam  
10 Legislature, going on to serve a total of five (5) terms as a Guam Senator, holding  
11 various distinguished positions, including Majority Leader; Chairperson of the  
12 Committee on Rules; Chairperson of the Committee on Health, Welfare, and Senior  
13 Citizens; Assistant Majority Leader; and she was a Member of the Committees on  
14 Health & Human Services, Natural Resources, Utilities & Micronesian Affairs, and  
15 General & Omnibus Matters; and

16 **WHEREAS**, always wanting to do more, Lou Leon Guerrero served as a Board  
17 Member for the Bank of Guam from 1991 to 1998, and again from 2001 to 2004,  
18 when she was named as Vice-Chairperson of the Board, a position she held until  
19 named as Chairperson in 2006, the position she currently holds, in addition to her role  
20 as the President and Chief Executive Officer for the Bank of Guam; and

21 **WHEREAS**, her thirst for knowledge and education unquenched, Lou Leon  
22 Guerrero returned to school in 2009, graduating with a diploma from the Pacific Coast  
23 Banking School in Seattle, Washington; and

24 **WHEREAS**, no matter how many hats Lou Leon Guerrero has worn, her will  
25 to serve remains unhindered, as she continues to be very engaged and involved with  
26 our island community, serving as a Board Member for the Guam Telephone

1 Authority; the Guam Memorial Hospital Authority; the *Ayuda* Foundation; the  
2 GuamPedia; and the Guam Chamber of Commerce; and also as the Chairperson for  
3 the Pacific Youth Center; as the Vice-Chairperson for the Guam Humanities Council;  
4 and as a member of the PEACE Council; and

5 **WHEREAS**, Lou Leon Guerrero has also held numerous officer and  
6 membership positions in the Guam Humanities Council; Mercy Action of the  
7 Marianas; the Guam Nurses Association; the American Cancer Society; the Guam  
8 Heart Association; the Guam Health Coordinating Council; and the Medical Quality  
9 Review Co. - District II; and

10 **WHEREAS**, Lou Leon Guerrero's numerous contributions to the community  
11 have not gone unnoticed, as she was selected to be in the Academy of Our Lady of  
12 Guam's Hall of Fame, and more recently, she was named as the Guam Business  
13 Magazine's 2010 "Executive of the Year"; the Guam Business Executive of the Year  
14 being an individual noted for: "Success and reputation in the business community,  
15 personal business creativity and entrepreneurship, leadership ability, business  
16 expansion, and community involvement;" and

17 **WHEREAS**, in recognition of Lou Leon Guerrero's achievements, countless  
18 contributions and years of service, including as a Member on the Board of Trustees of  
19 the Guam Memorial Hospital Authority as the Hospital received its first accreditation  
20 in almost thirty (30) years, high praise and honor are rightfully bestowed on the  
21 woman who has made seeking a better way of life for the entire island of Guam and  
22 its people, her life's mission; now, therefore, be it

23 **RESOLVED**, that *I Mina'Trentai Unu Na Liheslaturan Guåhan* does hereby,  
24 on behalf of *I Liheslaturan Guåhan* and the people of Guam, commend and

2 people; and be it further


3 **RESOLVED**, that the Speaker certify and the Legislative Secretary attest to,
