5 programs have made tremendous contributions to the institution's goal of teaching,
6 research, and service to the island community; and

7 **WHEREAS**, the University of Guam is celebrating its Ninth (9th) Annual
8 Student Employee and Supervisor of the Year Awards Program; and

9 **WHEREAS**, the purpose of the UOG Student Employee and Supervisor of the
10 Year Awards Program is to enhance the awareness of student employment and the
11 supervisor's role in mentoring student workers, and its importance in higher
12 education; and

14 Chan, Dr. Julie Ulloa-Heath, Mr. Edel Alon, and Mr. Perry Pangelinan, who represent
