WHEREAS, in 1993, the WVCST Alumni Association, Guam Chapter, was 8 9 established as a non-profit organization, and every year they have actively supported other non-profit organizations in Guam, such as the American Red Cross, the 10 11 American Cancer Society and the Guam Community College; and it is an active member of the Filipino Community of Guam, an umbrella association of more than 12 13 forty (40) Filipino groups in Guam; and have been supporting other disaster and relief operations of the Guam community, such as the recent earthquakes in China, Haiti, 14 15 Indonesia and Japan; and
