WHEREAS, Mr. Dave Shoji played his collegiate career as a setter at the 1 2 University of California, Santa Barbara, where he earned honors as a two (2) time All-3 American in 1968 and 1969; and 4 WHEREAS, Dave Shoji is known as a coach whose teams possess outstanding 5 ball control, and as such Dave has been honored with the title of the All-Time Great 6 Coach Award, in the Donald S. Shondell Contemporary Division of USA Volleyball in 2002; and he was also named as the Coach of the NCAA Division I Twenty-fifth 7 (25th) Anniversary Women's Volleyball Team in 2005, and was inducted into the 8 Hawaii Sports Hall of Fame in the same year; and 9 10 WHEREAS, Mr. Dave Shoji was named as the American Volleyball Coaches 11 Association National Coach of the Year twice, once in 1982, and the second time in 2009; and 12 WHEREAS, Mr. Dave Shoji was named as the AVCA West Region Coach of 13 14 the Year ten (10) times, and he was the Western Athletic Conference Coach of the 15 Year eleven (11) times; and WHEREAS, on December 16, 2010, Mr. Shoji was inducted into the AVCA 16 Hall of Fame; and 17 18 WHEREAS, in 2010, the University of Hawaii Rainbow Wahine captured their fourteen (14th) straight regular season Western Athletic Conference title, winning all 19 20 of the conference matches by sweeps for the first time in the University's history; and 21 WHEREAS, during the season, the UH Rainbow Wahine established school records with a sixty-two (62) set win streak, winning twenty-three (23) consecutive 22 matches, and eventually advancing to its twenty-ninth (29th) consecutive NCAA 23 24 Tournament; and

WHEREAS, in 2009, Mr. Dave Shoji became the second head coach in NCAA

Division I women's volleyball history to reach the one thousand (1,000) win

- 1 milestone, currently ranking him second all-time in Division I. Dave Shoji is the
- 2 longest tenured coach in women's volleyball and posts an amazing record with the
- 3 University of Hawaii Rainbow Wahine of one thousand forty-two (1,042) wins, one
- 4 hundred seventy-seven (177) losses, and one (1) tie; and
- 5 WHEREAS, Mr. Dave Shoji has guided the UH Rainbow Wahine to twenty-
- 6 five (25) NCAA Regional appearances, and eighteen (18) thirty (30)-plus win seasons,
- 7 and he has coached the UH Rainbow Wahine to four (4) National Championships,
- 8 including an AIAW title in 1979, and three (3) NCAA Division I crowns in 1982,
- 9 1983 and 1987; and
- 10 WHEREAS, Mr. Dave Shoji has coached twenty-four (24) AVCA All-
- 11 American athletes throughout his career as the UH Rainbow Wahine Head Coach,
- some of which have represented the United States volleyball teams in the Olympics,
- and others who became coaches at nationally accredited programs; now therefore, be
