- 3 WHEREAS, Mr. Paolo Benigno "Bam" A. Aquino was chosen by the
- 4 Philippine Consulate and the Filipino Community of Guam as the Keynote Speaker at

- the Guam Celebration Banquet commemorating the One Hundred Thirteenth (113th)
- 2 Anniversary of Philippines Independence Day, because of his impressive record of
- 3 service and outstanding commitment to his community; and
- 4 WHEREAS, Mr. Aquino has been the President of Microventures, Inc., since
- 5 June 2007, before which he was the Managing Director since January 2007.
- 6 Microventures, Inc., is a social business enterprise that assists in business
- 7 development for poor people through its partner micro-finance institutions, and it
- 8 currently runs the Hapinoy Program, which is a full-service support program for
- 9 micro-entrepreneurs in the Philippine rural areas; and
- 10 **WHEREAS,** since 2006, Mr. Aquino has also been the President of the *TAYO*
- 11 Foundation, which oversees the yearly search for the most outstanding youth
- organizations in the Philippines; and
- WHEREAS, "Bam" was the host of Start-up, a television show for budding
- 14 entrepreneurs, from November 2008 to August 2009; he was the host of Yspeak,
- 15 Studio 23, a youth-oriented debate show, from July 2006 to February 2007; and he
- was the host of Breakfast at Studio 23, a youth-oriented morning talk show on the
- 17 Philippine's premier news channel, ABS-CBM, from April 2001 to July 2006; and
- WHEREAS, Mr. Aquino was the editor of the ASEAN Fortieth (40th)
- 19 Anniversary book called Young Southeast Asia, which was published in 2007, that
- 20 focuses on young achievers in the region; and
- WHEREAS, Mr. Aquino was the President of Megamobile, Inc., a mobile
- 22 solutions provider for small and medium enterprises, from September 2006 to
- February 2008; and
- WHEREAS, Mr. Paolo Benign "Bam" A. Aquinas was also the Chairman and
- 25 Chief Executive Officer of the National Youth Commission, which is the chief youth
- 26 policy-making arm of the Philippine government, from February 2003 to February

- 1 2006, and he formerly served as the Commissioner-At-Large in the same Commission
- 2 from May 2001, prior to his appointment as Chairman; and
- 3 WHEREAS, from May 1999 to May 2000, Mr. Aquino was involved with
- 4 rehabilitation centers for abused and neglected children, disaster management, relief
- 5 operations, and volunteer recruitment, through the Special Projects Group of the ABS-
- 6 CBN Foundation; and
- WHEREAS, Mr. Paolo Benign "Bam" A. Aquinas was also a standout student
- 8 throughout his academic life, graduating as Valedictorian from both Atone de Manila
- 9 Grade School and Atone de Manila High School. He graduated with a Bachelor of
- 10 Science in Management Engineering from Atone de Manila University as Class
- 11 Valedictorian with Summa Cum Laude honors. "Bam" also attended the Atone de
- Manila Law School from 2000 to 2001, and the Kennedy School of Government at
- 13 Harvard University for an Executive Education Program on Public Policy and
- 14 Leadership in December 2008; and
- WHEREAS, Mr. Paolo Benign "Bam" A. Aquinas has been the recipient of
- many awards and recognitions throughout his young life, such as being named as one
- of the "Ten Outstanding Young Men of the Philippines 2010" by the Philippine
- Jaycees; the Co-Finalist for the "Ernst and Young Entrepreneur of the Year 2010;" the
- 19 "PLDT Bossing Co-Awardees 2010" in the Retail Financing Category, awarded by
- 20 the PLDT; the "GONegosyo Inspiring Young Entrepreneur 2010," awarded by
- 21 GoNegosyo; and the "Young Global Leader," by the World Economic Forum in
- 22 Canada in 2006; and
- WHEREAS, Mr. Aquino has also served as a member of the Board of the
- 24 Coca-Cola Foundation and Rags2Riches, Inc., since September 2007; as a member of
- Asia Society's Asia 21 Young Leader's Forum, since February 2006; as a member of
- 26 the Board of Trustees for Venture for Fund-Raising, since 2002; as the Ambassador

- for the Haribon Foundation, from March 2004 to March 2006; as the Chairman of the
- 2 ASEAN Ministerial Meeting on Youth in Manila, Philippines, in August 2003; and as
- 3 the spokesperson of The Children's Hour to raise resources for poor children through
- 4 donations, from 2002 to 2004; and
- 5 WHEREAS, Mr. Aquino served as President of the Ateneo de Manila
- 6 University Student Council, Sanggunian ng mga Mag-aaral, from 1998 to 1999; he
- 7 was a founding member and Constitutional Chairman of the National Union of

- 9 Outstanding Model Student of the Philippines", and was also one of the "Merit Top
