**Relative to recognizing and memorializing the late Honorable Juan Crisostomo Cruz, former Mayor of *Inarajan*, for his many achievements and accomplishments; and to further extending sincere condolences to his family, on behalf of *I Liheslaturan Guåhan* and the people of Guam.**

1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***  
2        ***MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN*:**

3        **WHEREAS**, the late Honorable Juan Crisostomo Cruz was born on September  
4        22, 1933, to the late Maria Crisostomo Cruz and the late Felix Dueñas Cruz, and he  
5        was called to his eternal reward on Monday, June 7, 2011, at the age of seventy-seven  
6        (77) years; and

1       **WHEREAS**, the late Honorable Juan Crisostomo Cruz married the former  
2 Maria Leon Guerrero Quinata, his soul mate, and from that union, Juan and Maria  
3 became the proud parents of eight (8) children, thirteen (13) grandchildren, and ten  
4 (10) great-grandchildren; and

5       **WHEREAS**, the late Honorable Juan Crisostomo Cruz retired from the Office  
6 Services Division, Officer in Charge of Construction, Marianas, as an Administrative  
7 Services Officer; and while employed there he had attended many training courses for  
8 his advancement, such as Fundamentals of Supervision, Basic Supervisory, Equal  
9 Employment Opportunity Counselor's, Role Supervisory Equal Employment  
10 Opportunity on Simplified Procurement, Methods and Techniques, Office  
11 Management on Civilian Employee Assistance, Program Seminar on Basic Creative  
12 Problem; and

13       **WHEREAS**, the late Honorable Juan Crisostomo Cruz devoted much of his  
14 time to his community, which included serving as the Scout Master, Troop 27,  
15 *Inarajan*; serving as a member of the *Inarajan* Parish Council; serving as the  
16 Treasurer for the *Inarajan* Civic Improvement; managing the Saint Joseph Basketball  
17 Team; serving as the Chairman for the Christmas Fund Raising for *Inarajan*  
18 Elementary School; and volunteering his services at the Saint Joseph Church in his  
19 beloved community; and

20       **WHEREAS**, the late Honorable Juan Crisostomo Cruz loved the land and  
21 worked tirelessly on the farm, and from his hard work he would share his crops with  
22 his relatives, friends and neighbors; and

23       **WHEREAS**, the late Honorable Juan Crisostomo Cruz was the last  
24 Commissioner of *Inarajan* to be denoted with the title of Commissioner, and the first  
25 to be denoted as the Mayor of *Inarajan*; and

1       **WHEREAS**, the late Honorable Juan Crisostomo Cruz, during his tenure as  
2 Commissioner and Mayor, administered numerous projects and programs that have  
3 socially, economically, and politically benefited the people of *Inarajan*; now  
4 therefore, be it

5       **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Unu Na*  
6 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the  
7 people of Guam, recognize and memorialize the late Honorable Juan Crisostomo  
8 Cruz, former Mayor of *Inarajan*, for his many achievements and accomplishments;  
9 and does further extend sincere condolences to his family on his passing; and be it

11       **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules  
12 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of  
13 the same be thereafter transmitted to the family of the late Honorable Juan Crisostomo  
14 Cruz; to the Mayors Council of Guam; and to the Honorable Edward J.B. Calvo, *I*  
15 *Maga'lahaen Guåhan*.
