12 eventually made his way to Guam, where he graduated from John F. Kennedy High
13 School; and in 1985, he attended the University of Guam, where he received a

17 matters, as well as serving and being involved in a number of civic and other
18 community organizations; to include serving as President of Luen Thai Fishing
19 Venture, Ltd.; President of Cosmos Distributing Co. Ltd. in Guam and Saipan;
20 President of Dickerson & Quinn Company, Ltd.; and he was a member of the Guam
21 Buildup and Economic Development Committee of the Governor's transition team;
