5   environment benefiting all island residents and businesses through overall improved  
6   services, lower costs, and innovative new services for *todu Guåhan*; and

7       **WHEREAS**, under Dan Moffat’s leadership, GTA TeleGuam has embodied  
8   the spirit of entrepreneurship by being first in providing innovative products and  
9   services, such as the Blackberry, the Apple iPhone, and digital television, as a first-  
10   time competitive offering for pay television service on Guam; and

11       **WHEREAS**, under Dan’s guidance, GTA TeleGuam has recruited, trained and  
12   developed a local management team and staff with deep knowledge and expertise in  
13   the areas of traditional telephony, broadband internet access, wireless  
14   communications, digital television, and emerging technologies; and

16   for Guam and the region with local talent and resources, Dan instilled a corporate  
17   philosophy of “*Always There*” for its customers and the GTA TeleGuam employees;  
18   and

19       **WHEREAS**, as part of that corporate philosophy, Dan has embraced the island  
20   community and the local culture by adopting and fostering our traditional values, such  
21   as *inafa’maolek, chenchule’*, and *respetu* for incorporation in its business practices to  
22   actively promote the well-being of the community; and


23       **WHEREAS**, in addition to introducing and providing cutting-edge services and

26   philanthropy with support to numerous worthy not-for-profit organizations that are


1 doing excellent work for the island and its residents; and he has encouraged his

18 Business Development Center; the Special Olympics; and the U.S. Navy League;


19 **RESOLVED**, that the Committee on Rules of *I Mina Trentai Unu Na*
