Relative to expressing the interest of *I Liheslaturan Guåhan* in exploring the possible establishment of a Sister City relationship and goodwill with the people of the province of Pangasinan, Republic of the Philippines, and the people of Guam.

## 1 BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I* 2 *MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN:*

WHEREAS, for centuries, the people of Guam have shared a strong bond with our brothers and sisters in the Republic of the Philippines; and with those who call Guam their home and who share their Filipino heritage, diversifying Guam's unique and strong culture and community; and 1 WHEREAS, over the years, many Filipinos have come to Guam to help build, 2 and sometimes rebuild, the community we know today; and many have also made 3 their homes here, have raised their families here, and have contributed to the 4 development and progress of Guam; and to the present day, the people of Guam, along 5 with our brothers and sisters from the Republic of Philippines, share in the excitement 6 of, and the expectations for, preparing for a future of unprecedented opportunities 7 towards the sustained growth of our island community; and

8 WHEREAS, in helping to prepare to make the most of future opportunities, it 9 would be worthwhile to explore the possibility of establishing a sister city relationship 10 between Guam and the Province of Pangasinan; further, non-profit organizations, such 11 as the Federation of Pangasinanses on Guam, designated as "Guam's Honorary 12 Ambassador-At-Large of Goodwill", can be the lead partners in ensuring that we 13 maximize this potential opportunity for both the people of Guam and the people of the 14 Province of Pangasinan, Republic of the Philippines; and

15 WHEREAS, the Federation of Pangasinanses on Guam, with its President, 16 Major Vic R. Rivo, Sr. (Ret.), is leading a delegation to the Province of Pangasinan, Republic of the Philippines at the invitation of both the Honorable Amado T. Espino, 17 18 Jr., Governor of the Province of Pangasinan, Republic of the Philippines, and the 19 Honorable Jose Ferdinand Z. Calimlim, Jr., the Vice Governor and Presiding Officer of the Provincial Board of the Province of Pangasinan, Republic of the Philippines, 20 21 which will highlight the relations of the people of the Province of Pangasinan, 22 Republic of the Philippines with the people of Guam; now therefore, be it
