1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN:***

1 **WHEREAS**, a group of one hundred sixty-five (165) high school students and
2 their advisers from Japan visited Guam for the purpose of showing respect and
3 extending prayers for those who died on Guam during World War II; and

4 **WHEREAS**, the students visited the War in the Pacific National Park, Gaan
5 Point, the *Faha* Massacre site, and the *Manenggon* Memorial Park in order to better
6 understand the horrors of war and its effects on both the innocent civilians caught in its
7 wake, and the soldiers who fought it; and

8 **WHEREAS**, it is hoped that this will continue to be an annual trip, and that the
9 tributes paid by these students will shine as an example that will encourage other
10 students and organizations from Japan to make similar trips; and

11 **WHEREAS**, the *U.S. Explore and Study, Inc.* has been instrumental in trying to
12 heal the wounds of World War II, and the tensions over the war between the people of
13 Guam, Japan and the United States; and it has held ceremonies and tributes in past years
14 with that noble aim; and

15 **WHEREAS**, the *U.S. Explore and Study, Inc.*, along with its President, Mr.
16 Kensuke Haga, have worked extremely hard to move towards these goals, and
17 especially to help organize this trip by Japanese high school students; now therefore, be
18 it

19 **RESOLVED**, that the Committee on Rules of *I Mina' Trentai Unu Na*
20 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
21 of Guam, highly commend and thank the Principal, Teachers and Students from
22 Kanagawa Kenritsu Oohara High School of Kanagawa Prefecture, Japan, for visiting
23 Guam and the World War II sites, and for honoring those who died at those sites with
24 their prayers and tributes; and does further extend *Un Dangkolo Na Si Yu'us Ma'ase* to
25 Mr. Kensuke Haga and the *U.S. Explore and Study Inc.* for their work on the project;

2 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of

6 *Maga'lahaenGuåhan*.


