WHEREAS, Lou led the initiative in organizing the Micronesian Road Show, which was started in 2008 with Continental Airlines and the national tourism offices to promote travel from Australia to the region, by working with Tropical Tourism of Northern Queensland in Cairns to host a Micronesia products seminar with travel and tour agencies from Cairns; and now the event has grown to become a three (3)-city travel road show promoting travel to the region, with the participation of the tourism offices of Pohnpei, Kosrae, Chuuk, Yap and Palau; and

WHEREAS, Lou regularly collaborated with the U.S. Navy and the U.S. Air Force regarding its annual travel show, and she made it a priority to seek military support for the Guam Micronesia Island Fair to showcase the local culture
