1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**

4        founded in 1991, with its Constitution and By-Laws duly adopted by the Board of

1       **WHEREAS**, the mission of the EASGC is to encourage and promote the game  
2 of golf, to encourage the EASGC members' participation in civic and community  
3 functions, and to support social functions for the EASGC members and fellow golfers;

5       **WHEREAS**, the organization currently has sixty-three (63) members actively  
6 involved in carrying out the mission of EASGC; and

7       **WHEREAS**, the membership of the EASGC consists mainly of engineers,  
8 architects, surveyors, business owners and executives; and both active and retired  
9 military servicemen; and

10       **WHEREAS**, the group meets every Sunday for a round of golf at various  
11 scheduled golf courses around the island, in order to foster a spirit of camaraderie  
12 among its members; and

13       **WHEREAS**, the EASGC holds a general membership meeting every first  
14 Monday of the month at a designated hotel on island; and for the last two (2) years has  
15 been holding its monthly meetings at the Guam Reef Hotel; and

16       **WHEREAS**, since 1994, the Engineers, Architects and Surveyors Golf Club  
17 has been hosting the JFT Island Wide Golf Tournament to raise funds for various  
18 charitable organizations, such as the Make A Wish Foundation; the *Alee* Shelter; the  
19 University of Guam Endowment Foundation; *Kamalen Karidat*; and the Guam  
20 Shriners; and

21       **WHEREAS**, the EASGC had made contributions to assist disaster victims, and  
22 they helped to establish an orphanage in the Philippines; and

23       **WHEREAS**, the EASGC also provided monetary support to fund scholarships  
24 for deserving students at the University of Guam; and

25       **WHEREAS**, the past presidents of the Engineers, Architects and Surveyors  
26 Golf Club are: Mr. Ed Hipona, Mr. Nars Guertes, Mr. Vic Ovalles, Mr. Efren Tanag,

1 Mr. Rene Alcazaren, Mr. Roger Ruelos, Mr. Art Chan, Mr. Armand Cayand, Mr. Bob  
2 Field, Mr. Ted Abella, Mr. Angel Mendoza, Mr. PJ Jose, Mr. Vic Dew Roca, Mr.  
3 Rick Unpingco, Mr. Dubel Conlu, Mr. Nemy Macario, Mr. Ding Vales, Mr. Warly  
4 Gaid, Mr. Rene H. Ramos, Mr. James Badong, and Mr. Enrico Gloton; and they have  
5 all played a vital role in leading the club over the past twenty (20) years; and

6 **WHEREAS**, the newly-elected 2012 EASGC Officers are: President-elect  
7 Bernie Maranan; Vice President-elect Ben Reyes; Treasurer-elect Pascual Jasa;

21 Calvo, *I Maga'lahaen Guåhan*.


