**Relative to approving the expenditure of Ten Thousand Dollars (\$10,000.00) from the Central Operations Budget of *I Mina'Trentai Unu Na Liheslaturan Guåhan* for the administrative and operational costs associated with the Legislature Television Channel.**

**BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN*:**

**WHEREAS**, in March 2011, *I Mina'Trentai Unu Na Liheslaturan Guåhan* adopted Resolution No. 18-31 (COR) – “Relative to approving the expenditure of Four Thousand Nine Hundred Dollars (\$4,900.00) from the Central Operations Budget of *I Mina'Trentai Unu Na Liheslaturan Guåhan* for the purchase of computer hardware, software and video production equipment for the enhancement of production capabilities for the Legislature Television Channel”; and

**WHEREAS**, *I Mina'Trentai Unu Na Liheslaturan Guåhan* utilizes this newly purchased equipment for the production, content management, and on and off-site video recording of public hearings and meetings, official state functions, and various other legislative events, including slides and various messages and greetings from all senatorial offices for broadcasting on the Legislature Channel; and

1       **WHEREAS**, *I Mina'Trentai Unu Na Liheslaturan Guåhan* recognizes that  
2 there are administrative and operational costs associated with the production of  
3 content for the Legislature Television Channel, which must be supported to  
4 continue to maintain the level of transparency and accountability that *I Liheslatura*  
5 strives to provide to the people of Guam; now therefore, be it

6       **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Unu Na*  
7 *Liheslaturan Guåhan*, on behalf of *I Liheslaturan Guåhan* and the people of  
8 Guam, does hereby approve the expenditure of Ten Thousand Dollars (\$10,000.00)  
9 from the Central Operations Budget of *I Mina'Trentai Unu Na Liheslaturan*  
10 *Guåhan* for the administrative and operational costs associated with the Legislature  
11 Television Channel; and be it further

12       **RESOLVED**, that the Speaker and the Chairperson of the Committee on  
13 Rules certify, and the Legislative Secretary attest to, the adoption hereof, and that  
14 copies of the same be thereafter transmitted to Mr. Vincent P. Arriola, Executive  
15 Director, *I Mina'Trentai Unu Na Liheslaturan Guåhan*; and to the Honorable  
16 Edward J.B. Calvo, *I Maga'lahren Guåhan*.
