Yeoh entered into the AGA 13 14 National's competition to prepare a citizen-centric report for the city of Alexandria, Virginia, to include a paper that summarizes the criteria and the justification the team 15 16 used to decide what information to include and exclude in the performance report; and 17 WHEREAS, the UOG team of Brobesong, Clemente, Castro and Yeoh, 18 successfully placed as one (1) of the top three (3) finalist teams, along with Old 19 Dominion University, and the University of North Carolina at Pembroke; and 20 WHEREAS, all finalist teams were awarded scholarships to attend the AGA's Tenth (10th) Annual National Leadership Conference in Washington, D.C., which the 21 22 UOG team accepted; and WHEREAS, I Liheslaturan Guåhan, through the adoption of Resolution No. 23 308-31 (LS), recognized, commended, and offered its best wishes to the UOG team, 24

which attended the Conference from February 16-17, 2012; and
