3 **WHEREAS, Tagada Guam, LLC, is a local company which was established on**
4 **October 26, 2010; and**

1 **WHEREAS**, the Tagada Guam Amusement Park is located in the village of
2 *Tumon*, between the Ohana Bay Resort and Pacific Place, which is a convenient and
3 attractive location accessible for local residents and visitors; and

4 **WHEREAS**, the amusement park provides a benefit to the local community by
5 establishing an entertainment and a recreational facility. In addition, Tagada
6 Amusement Park offers local discounted rates to residents and students to promote
7 local patronage; and

8 **WHEREAS**, the Tagada Guam Amusement Park is divided into two (2)
9 phases. The first (1st) phase is set to open on March 16, 2012, which consists of three
10 (3) rides, including a huge swing called “The Viking”; a gravity-defying ride called
11 the “Tagada”; and Bumper Cars to complete the first (1st) phase. The second (2nd)
12 phase of the amusement park will consist of an Inflatable Balloon Ride rising up to
13 one hundred (100) feet above the ground, and a Three Dimensional (3D) Plane Ride;

15 **WHEREAS**, Tagada Guam, LLC, contributes to the tourism industry by
16 offering an additional attraction for visitors, and a source of revenue for Guam; and

17 **WHEREAS**, Tagada Guam, LLC, provides local employment to about twelve
18 (12) local residents to operate the amusement park, and contributes to the local
19 economy; now therefore, be it

20 **RESOLVED**, that *I Mina’Trentai Unu Na Liheslaturan Guåhan* does hereby,
21 on behalf of the people of Guam, congratulate Tagada Guam, LLC, on the opening of
22 the Tagada Amusement Park; and does further commend Tagada Guam, LLC, for its
23 confidence in our local economy, as well as for its contribution in providing a better
24 *Tumon* experience for our local residents and visitors by launching a two (2)-phased
25 amusement park on the island of Guam; and be it further
