14 the “Valor Award” for bravery, and for his ability to render life saving services;

24 Ministry; and


25 **WHEREAS**, for his outstanding contributions and service to the parish

27 “2012 Grand Marshall” in the celebration of *Fiestan Inalahan* – Patrocino in honor


1 of the Patron Saint, San Jose; he will lead the village parade on Sunday, May 5,
