3        **WHEREAS,** Riko San Nicolas Crisostomo is the son of Francisco (Frank)  
4        Meno Crisostomo and Martha (Mardy) Ann Crisostomo; he is the grandson of †Mr.  
5        Vincente and †Mrs. Maria Meno Crisostomo; and †Mr. Vicente C. and †Mrs. Ana T.  
6        San Nicolas; and his siblings are Joevince San Nicolas and Ankie Crisostomo; and

1       **WHEREAS**, Riko was born on July 19, 1991. He attended *Talofofa*  
2 Elementary School, *Inarajan* Middle School, and graduated from Southern High  
3 School (SHS) in 2009. He is presently a full-time student at the University of Guam  
4 studying Criminal Justice; and

5       **WHEREAS**, Riko was the recipient of many prestigious awards, such as the  
6 SHS JROTC-Sons of American Revolution Award; and the Superior Cadet Award; he  
7 ranked first place in the Multiple School Unit Guam (MSUG) 2009 Color Guard  
8 Saber Team, and went on to represent Guam in the Golden Bear West Coast Nationals  
9 in California, where he placed second (2<sup>nd</sup>) in the Color Guard Competition; and

10       **WHEREAS**, Riko enjoys playing baseball and basketball, but most especially  
11 serving in Eucharistic Celebrations. He has been faithfully serving God and the Parish  
12 of San Isidro as an Altar Server since 2000. Riko has also helped newly assigned  
13 priests transition into the San Isidro Parish community. Since his years of service  
14 began, Riko has served under Father Manuel “Jun” Trenchera, Father James Bejer,  
15 Father Kenneth Carriveau, Father Hector Canon, and now Father Romeo “Romy”  
16 Convocar. His active participation in the Church and throughout the village  
17 demonstrates his love and devotion to God and the community; and

18       **WHEREAS**, Riko serves the Church and his parish community as a member of  
19 the San Isidro “SIAH” Youth Group; and he has taken on the role of publishing and  
20 printing the Sunday bulletin. He also volunteers during the Parish’s “Raise the Roof”  
21 fundraiser events; he is a Catechist for the grades 8 through 11 Holy Communion  
22 class; and he assists with the CCD classes; also, he had served as a member of the  
23 2011 World Youth Day Committee, which was sponsored by the San Isidro Parish;  
24 and from 2007 to 2010, he had participated with the Saturday Youth Mass Choir, as a  
25 guitarist and singer; and

2 community, Riko has been selected to serve as this year's "2012 Grand Marshall", to  
3 lead the parade in celebration of the *Malojloj* Fiesta in honor of San Isidro, the

6 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people  
7 of Guam, recognize and congratulate Mr. Riko San Nicolas Crisostomo on being  
8 selected as the "2012 Grand Marshall" of the *Malojloj* Fiesta Parade; does commend  
9 him for his many accomplishments and invaluable contributions; and does further
