17 achieve a favorable outcome; and


18       **WHEREAS**, Fire Lieutenant Tomas D.P. Fegurgur was selected as the

21 of pre-hospital patient care; now therefore, be it


22       **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Unu Na*
