- WHEREAS, Brian Pak earned his Bachelor's Degree in Engineering from the

1	WHEREAS, when Brian was growing up, he had dreamt of being a CEO of a
2	large corporation; and this dream led him to start up his own company in 1993, which
3	was called Intercontinental Management Consultants Inc., which did consulting work
4	for construction and project management and operated a bus and tour company,
5	employing around seventy (70) workers; and
6	WHEREAS, in 1999, after nearly eight (8) years of being in business, Brian
7	Pak discontinued the operations of his company to be able to spend more time with his
8	family; and
9	WHEREAS, after taking some time off to be with his family, Brian Pak was
10	contacted by his friend, Charles "Chuck" Abbott, who was then the General Manager
11	of the Westin Resort Guam, to come work for him at the Hotel; and
12	WHEREAS, it was then that Brian Pak began his career in the hotel industry,
13	serving as the Sales and Revenue Manager for the Westin Resort Guam; and
14	WHEREAS, after working for four (4) years at the Westin Resort Guam, Brian
15	Pak was then transferred to W Hotels Seoul in South Korea as part of its opening
16	team; and
17	WHEREAS, his work at W Hotels Seoul led him to the Ken Corp. Group,
18	where he currently holds the seat as Vice President; and
19	WHEREAS, through Ken Corp., Brian Pak was assigned to the Aqua Resort
20	Club in Saipan, where he served as General Manager for ten (10) months before
21	returning to Guam; and
22	WHEREAS, after serving for six (6) years in the Ken Corp. Hotel Operations
23	and Management, Brian Pak was elected to serve as one (1) of the four (4) Managing
24	Directors to oversee all seven (7) hotels and one (1) golf course in the Micronesia
25	area; and

l	WHEREAS, Brian Pak also managed the Hotel Santa Fe and the then-Palace
2	Hotel; and he remained at the Palace Hotel after the Hotel Santa Fe was sold; and
3	WHEREAS, in November 2006, the Palace Hotel was closed to undergo a
4	major renovation and rebranding, with Brian Pak leading the Hotel's renovation team,
5	and opening the Sheraton Laguna Guam Resort in April 2007; and
6	WHEREAS, in 2009, Brian Pak was asked to take over as the Managing
7	Director of the Country Club of the Pacific Golf Course (CCP); and
8	WHEREAS, Brian Pak's role at the CCP was to oversee its operations and to
9	provide a direction for its success; and he led CCP to be considered as one of the
10	premier golf courses in Guam and the Marianas; and
11	WHEREAS, outside of work, Brian Pak enjoys spending time with his family,
12	and playing golf, and his newfound hobby, tennis; and he also enjoys playing with his
13	Cavalier King Charles Spaniard, named Charlie; now therefore, be it
14	RESOLVED, that the Committee on Rules of I Mina'Trentai Unu Na
15	Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the people
16	of Guam, recognize and commend Mr. Brian Pak for his outstanding service and
