8 Officer II to Revenue Officer III; and

9 **WHEREAS**, Ms. Fejeran had received the Department of Administration's
10 Special Achievement Recognition Award, on January 16, 2009; and

11 **WHEREAS**, Ms. Fejeran has four (4) children: Anthony Jr., Rick, Tymia Ann
12 and Catherine Rose, who are her biggest supporters for the hard work she has done
13 over the past twenty-eight (28) years; now therefore, be it

15 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
