**Resolution No. 559-31 (COR)**

**Relative to recognizing the passing of the late Gloria Borja Nelson, former elected member of both the Territorial Board of Education and the Consolidated Commission on Utilities, and to approving that a State Funeral be conducted in her honor, in accordance with the Standing Rules of *I Liheslatura* and with Title 1, Guam Code Annotated, Chapter 4, §419.**

**BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN*:**

**WHEREAS**, the late Gloria Borja Nelson served the people of Guam in numerous capacities throughout the years, including her service as an elected official for the Territorial Board of Education, and also as an elected official of the Consolidated Commission on Utilities; and

**WHEREAS**, the Committee on Rules has taken note that the late Gloria B. Nelson has displayed exemplary service for the island and the people of Guam, and the Committee on Rules of *I Liheslatura* desires to conduct a State Funeral to honor the late Mrs. Nelson, in order to memorialize the many contributions she has made in numerous capacities throughout her lifetime; and

**WHEREAS**, as set out in *I Mina'Trentai' Unu Na Liheslaturan Guåhan's* Standing Rules, the Committee on Rules hereby authorizes the expenditures for the State Funeral of the late Gloria Borja Nelson; now therefore, be it

1           **RESOLVED**, that the Committee on Rules does hereby authorize a State  
2 Funeral to be conducted for the late Gloria Borja Nelson, in accordance with the  
3 provisions of §419 of Chapter 4, Title 1, Guam Code Annotated, and the  
4 provisions of the Standing Rules of *I Mina'Trentai' Unu Na Liheslaturan Guåhan*;  
5 and be it further


6           **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules


