WHEREAS, Shelly V. Calvo discovered her passion for cooking and good
food at a very young age. With the guidance of her grandmother, who was a

restaurateur, and her mother who had the same passion for cooking, Shelly started
 creating her recipes as early as the age of twelve (12); and

WHEREAS, in 2002, Shelly opened a catering company in the Philippines, which was called FUD, and which also delivered packed lunches to business offices in the Makati district. In 2004, Shelly moved to Guam and opened "Club Manila", which became famous for its "pupus" that were made with Shelly's recipes. In 2006, she also opened "The Whole Enchilada", a Mexican restaurant featuring her best Mexican dishes; and

9 WHEREAS, Shelly was always innovative and finding ways to express her 10 talents and skills to the community around her. In 2007 shortly after opening her 11 restaurant, Shelly started writing her own column, the Dining Diva, which is a 12 weekly feature in the Pacific Daily News. Her column focuses on inspiring 13 individuals to better appreciate life in general, as it promotes perseverance, life understanding, goal-attainment, and overcoming hardships. 14 The Dining Diva 15 column has been very successful as it gained attention in the community, while 16 also sharing her original recipes. Her recipes are also a commemoration of the 17 past, inspired by Guam's palette, and a giver of inspiration to creating better dishes 18 in the future; and

19 WHEREAS, in her efforts to inspire her readers even more, Shelly has 20 decided to create this monumental project that took over a year to complete. A 21 year ago, she started creating recipes to compile for her first cookbook. Shelly 22 wanted to create a special culinary compilation so she also added original inspirational thoughts she has created, thus the birthing of the Cooking A La Diva 23 24 Inspirational cookbook. The recipes in the book have never been published in her 25 column. In this cookbook, Shelly also extended the opportunity to inspire the 26 community by inviting inspirational women of Guam to submit their stories and 27 delicious recipes; and

WHEREAS, today, Shelly is involved in various projects and also manages
 the "Diva Café", which opened in 2011 and serves healthy and delicious recipes. In
 addition, she is the president of "MASA Bar & Restaurant"; and

WHEREAS, Shelly has been active in her civic and humanitarian efforts as she continues to participate and take membership in various community efforts throughout the island. She is currently the elected Chairwoman of the Board of the Guam Homeless Coalition; the President of the Capizenos Association of Guam; the treasurer of the *Hagatña* Restoration and Revitalization Authority; a member of Lion's Club Guamerica; and a Director of the Filipino Community of Guam; and

WHEREAS, Shelly Calvo is also celebrating five (5) years of success with her *Dining Diva* column of the Pacific Daily News, which had inspired the inception of her cookbook. Her inspirational cookbook will also benefit the Guam Homeless Coalition as she has pledged to donate a portion of her book sales to the Coalition; now therefore, be it
