- 5 brothers and sisters. He has seven (7) children: Mike, Jessica, Vanderick, Frankie,
- 6 Patrick, Manet and Robert; and is also blessed with twelve (12) grandchildren; and

1 WHEREAS, Frank attended *Inarajan* Elementary School for his grade 2 school education; and he graduated from *Inarajan* High School in 1972; and 3 WHEREAS, in 1981, Mr. Tedtaotao started his government of Guam career 4 working as a Community Program Aide I at the Department of Public Health and 5 Social Services (DPHSS). In 1986, he switched jobs and became a Maintenance Worker; and 6 7 WHEREAS, in 1987, Frank was asked to take over the duties of the Supply 8 Supervisor who retired due to illness. He agreed to oversee the Supply Section 9 since he knew that it was a critical position in the Department. For his efforts, 10 Frank was granted a step increase for his exceptional work; and 11 WHEREAS, in 1988, Frank transferred to the position of Supply Clerk, and 12 he was later promoted to his current position as Inventory Management Officer in 13 the same year. Mr. Tedtaotao supervised and directed the overall activities of the 14 inventory management, procurement, and property control of the Department. He 15 planned, developed, and implemented property disposal operations between the 16 various divisions, bureaus and sections of the DPHSS and the General Services 17 Agency (GSA); and WHEREAS, Frank also conducted and maintained the fixed asset inventory 18 19 of the Department, and he verified the deliveries of equipment and supplies to the 20 Department. He prepared survey reports and coordinated the transfer of surveyed 21 items to GSA. He served as the liaison for the Guam Telephone Authority, and 22 made sure that telephone services were not disrupted at the Department; and WHEREAS, Mr. Tedtaotao was very professional with his work as he also 23 24 received numerous Outstanding Performance Evaluations during his thirty-two 25 (32) year career at DPHSS; and WHEREAS, having worked for thirty-two (32) years with the government 26

of Guam, Frank is a man of experience and he will truly be missed by his
