2 residents of *Yona* were attended to; and


3 **WHEREAS**, in addition to his duties and responsibilities as Mayor of *Yona*,

16 now therefore, be it;


17 **RESOLVED**, that *I Mina'Trentai Unu Na Liheslaturan Guåhan* does
