16 home and sent for his wife Nieva, and sons Leonardo and Martin; and

17 **WHEREAS**, Mr. Roldan’s family grew with the birth of Elizabeth,
18 Doris, Grace and John; and

19 **WHEREAS**, his Roldan family name is firmly established in NCS,
20 (Gugagon Village) Dededo, and spans four (4) generations.
