Relative to commending and congratulating the Ilocano Association of Guam (ILOAG) for its efforts in implementing noteworthy community projects on Guam and on its 46<sup>th</sup> Anniversary Celebration.

**BE IT RESOLVED BY I MINA'TRENTAI UNO NA LIHESLATURAN GUÅHAN:**

1       **WHEREAS**, the Ilocano Association of Guam was established thirty years ago, as a  
2       non-profit civic and social organization, whereby Ilocano's on Guam could maintain a  
3       bond of camaraderie, friendship, and togetherness; and

4       **WHEREAS**, the Ilocano Association of Guam has been sponsoring annual  
5       fundraising activities in order to raise money to fund its community projects; and

6       **WHEREAS**, the Ilocano Association of Guam, over the past several years, has paid  
7       for picnic shelters at Ypao Beach and at the Tamuning Mayor's Office, statues at John F.  
8       Kennedy and George Washington High Schools, a lighted sign facility at the Government  
9       House, tennis courts at JFK, and medical equipment to Guam Memorial Hospital; and

10       **WHEREAS**, the Ilocano Association of Guam, with the support of Mayor Melissa  
11       Savares of Dededo, her municipal planning council, Senator Adolpho B. Palacios, Sr., the

1 main sponsor of Bill No. 471-30 (COR) which became Public Law No. 30-238, Senator Tina  
2 Rose Muna-Barnes of the Committee overseeing the Guam Housing and Urban Renewal  
3 Authority (GHURA) and co-sponsor of Public Law No. 30-238, Senator Dennis G.  
4 Rodriguez, Jr., Chairman of the Committee overseeing senior citizens, and Mr. Arthur San  
5 Agustin, now the Acting Director of the Department of Public Health and Social Services,  
6 has applied for a Community Development Block Grant funding to GHURA for Fiscal Year  
7 2010; and

8       **WHEREAS,** the Ilocano Association of Guam has been recently awarded a federal  
9 grant of \$800,000 by GHURA to complete its clubhouse, construct a multi-purpose  
10 community center, and a basketball court facility for public usage; and

11       **WHEREAS,** the Ilocano Association of Guam has stipulated in their grant  
12 application to GHURA that it will operate a senior citizens center and provide other  
13 innovative services to the residents of the Macheche Subdivision and neighboring areas;  
14 and

15       **WHEREAS,** with their planned project the Ilocano Association of Guam becomes  
16 the first non-profit civic Filipino organization on Guam to elevate its purpose to the most  
17 sublime responsibility of providing services to the community of Dededo; and

18       **WHEREAS,** the Ilocano Association of Guam will be celebrating its 46<sup>th</sup> Anniversary  
19 on March 5, 2011 and its induction of officers and board of directors; now, therefore, be it

1           **RESOLVED**, that *I Mina'Trentai Unu na Liheslaturan Guåhan* does hereby, on behalf  
2 of the people of Guam, congratulate the Ilocano Association of Guam on the occasion of the  
3 celebration of its 46<sup>th</sup> Anniversary on March 5, 2011; and be it further

4           **RESOLVED**, that *I Mina'Trentai Uno na Liheslaturan Guåhan* does hereby, further  
5 extends its commendation and gratitude to the Ilocano Association of Guam for their many  
6 contributions to the local community of Guam; and be it further

7           **RESOLVED**, that the Speaker certify and the Secretary of the Legislature attest to,  
8 the adoption hereof, and that copies of the same be thereafter transmitted to Mr. Ernie Cid,  
9 President of the Ilocano Association of Guam; to the Consul General of the Republic of the  
10 Philippines; and to the Honorable Edward J. B. Calvo, *I Maga'lahren Guåhan*.
