YU'OS MA'ASE' TO HIM FOR THE OUTSTANDING  
CONTRIBUTIONS HE HAD MADE TO THE BETTERMENT  
OF OUR ISLAND COMMUNITY; AND TO  
ENCOURAGING HIS FURTHER EFFORTS FOR OUR  
ISLAND AND THE PACIFIC DURING THIS THIS 3<sup>RD</sup>  
ANNUAL MARC AND CHARTER DAY EVENT.

1 BE IT RESOLVED BY *I MINA'TRENTA NA LIHESLATURAN*  
2 *GUÅHAN*:

3 WHEREAS, Pastor Edmund Kalau has served the People of  
4 Micronesia for over 60 years, and contributed to the medical, cultural and  
5 historical wellbeing of our people in a myriad of ways; and

6 WHEREAS, Mr. Kalau founded the Pacific Missionary Aviation and  
7 provided essential medical services to Guam and Micronesia for over thirty  
8 five years; and

9           **WHEREAS**, upon his retirement approximately six (6) years ago  
10 from Pacific Missionary Aviation, he established the Micronesian Youth  
11 and Family Services non-profit, in the aim of helping our immigrants from  
12 the Federated States integrate into the Guam community successfully; and

13           **WHEREAS**, Pastor Edmund Kalau has contributed greatly to the  
14 cultural preservation of our region through his role as a Historian and  
15 Anthropology recorder for Micronesia, wherein he collects and documents  
16 critical information for the preservation of our Pacific cultures; and

17           **WHEREAS**, the Pastor has been a vital player in the diverse historical  
18 and cultural preservation and perpetuation in Micronesia, beyond his  
19 duties at the Pacific Missionary Aviation and the Micronesian Youth and  
20 Family Services but also in his everyday life and personal efforts; and

21           **WHEREAS**, the Micronesian Area Research Center (MARC) has  
22 chosen to officially and publicly recognize his contributions to our  
23 community at the 3<sup>rd</sup> Annual MARC and Charter Day Event; now,  
24 therefore, be it

25           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Unu Na*  
26 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the  
27 People of Guam, recognize Pastor Edmund Kalau for his service and  
28 dedication to the People of Guam and Micronesia; and does extend a  
29 sincere *Un Dangkolo Na Si Yu'os Ma'ase'* to Pastor Kalau for his  
30 undertakings; and be it further

31       **RESOLVED**, that the Speaker and the Chairperson on the Committee  
32 on Rules certify, and the Legislative Secretary attest to, the adoption hereof,  
33 and that copies of the same be thereafter transmitted to Pastor Edmund  
34 Kalau and to the Honorable Governor Edward Calvo, *I Maga'lahaen Guåhan*.
