1       **WHEREAS**, EVA Air was established in March of 1989 by Dr. Chang Yung-Fa,  
2       Evergreen Group Chairman and founder; and

3       **WHEREAS**, EVA Air raises the impeccable transportation heritage and tradition  
4       of quality service long established by Evergreen Marine Corporation to new heights;  
5       and

6       **WHEREAS**, EVA Air made their maiden flight on July 1, 1991; and

7       **WHEREAS**, since its inaugural flight, EVA Air have created a global air  
8       transportation network by establishing a network of destinations that span the globe,  
9       stretching through Europe, North America, Asia, and Oceania; and

10           **WHEREAS**, EVA Air has carefully developed alliances with major carriers  
11 worldwide which gives them a far-reaching service network that benefits both  
12 passenger and cargo customers ; and

13           **WHEREAS**, EVA Air has formed core values promoting safe and punctual  
14 flights, friendly and professional services, and innovative and efficient operations,

16 challenge, and teamwork; and

17           **WHEREAS**, in 1992, EVA Air laid the airline industry with the introduction of  
18 their premium economy service, now named Elite Class, and emulated in concept by  
19 other carriers around the world; and

20           **WHEREAS**, in 2005, EVA Air upgraded the Elite Class with the launch of their  
21 brand new Boeing 777-300R's; and

22           **WHEREAS**, EVA Air has been recognized worldwide for their flight safety  
23 record; and

24           **WHEREAS**, EVA Air has been awarded the coveted Gold Wing by Taiwan's  
25 Civil Aeronautics Administration; and

26           **WHEREAS**, EVA Air has been ranked year after year as one of the world's top 10  
27 (ten) safest carries by Germany's *Aero International Magazine*; now, therefore, be it
