6 at his Old Town Chinese Restaurants; and

7 **WHEREAS**, Mr. Jerry Li has made Guam his home and has established
8 these restaurants to provide valuable service and quality food to the people of
9 Guam; and

10 **WHEREAS**, he is a proud member of the United Chinese Association of
11 Guam;

12 **WHEREAS**, Mr. Li is an active member of the Chinese Chamber of
13 Commerce of Guam; and

14 **WHEREAS**, Mr. Jerry Li has also received an award from the Chinese
15 Chamber of Commerce of Guam for being an outstanding member; and now,
16 therefore be it

18 recognize and congratulate Mr. Jerry Li, his family and staff on the grand opening
