

WHEREAS, Linda U. Del Rosario, Management Analyst III, retires on July 29, 2011, after completing 36 years of actual government service and holding 11 position titles within the Department of Public Health and Social Services; and,

WHEREAS, on June 2, 1975, Ms. Del Rosario began her career with the government as a Clerk III with the Division of Public Welfare, Child Protective Services with an hourly rate of \$3.33; and,

WHEREAS, as she worked with the Child Protective Services from 1975 through 1984 she was elevated to a Clerk Typist IV and then to a Secretary I Typist; and,

WHEREAS, in 1984 she joined the staff of the Bureau of Economic Security as an Assistant Payment Worker I, and through her career with the Bureau which spanned through 2001, was promoted to an Assistance Payment Worker II, reclassified to an Eligibility Specialist II, promoted to a Social Services Field

Representative I, reclassified to a Quality Control Reviewer II, promoted to a Social Services Field Representative II, and then reclassified as a Quality Control Supervisor; and,

WHEREAS, in 1993 for her outstanding achievement, received the Governor's Magnificent Seven Award for Supervisor of the Year; and,

WHEREAS, in 2001, after 26 years with the Division of Public Welfare and helping the needy and most vulnerable members of our community, was promoted to Management Analyst III with the Division of General Administration; and,

WHEREAS, throughout the next 10 years, she served as the Personnel Officer of the Department assisting hundreds of staff as they entered and exited the Department, and in between, providing them administrative guidance on personnel issues; and,

WHEREAS, as a long-time member of the Department of Public Health and Social Services family, she is recognized for her outstanding work for the department and will be missed for her humor and enthusiastic and animated demeanor; now, therefore, be it

RESOLVED, that I Mina'trentai Unu na Liheslaturan Guåhan does hereby commend and congratulate Ms. Linda U. Del Rosario on the occasion of her retirement from the Department of Public Health and Social Services and the Government of Guam; and express a sincere Un Dangkulu Na Si Yu'os Ma'åse to her children, Jenna Lyn and Cole, and grandchildren, Tori Lynn, Tayler, Tia Rose, and Cody, in recognition of their mother and grandmother's 36 years of service; and does further extend best wishes to Ms. Del Rosario as she enters the ranks of the retired class, though will not be fully retired, as she now enters the dynamic world of private business; and be it further
