- 5 **WHEREAS,** Mr. Luis S.N. Reyes is married to Pacita A. Reyes and
- 6 they are the parents of three (3) daughters; and Luis earned his General
- 7 Education Development (GED), University of Guam in 1961; Bachelor's of
- 8 Arts (B.A.) with a Major in Psychology and a Minor in Sociology where he
- 9 graduated Cum Laude, University of Guam in 1973; Luis continued his
- 10 education earning a Master of Education Degree in Guidance and
- 11 Counseling, University of Guam in 1974; and,
- 12 **WHEREAS**, Luis' first job was as a custodian with Federal Civil
- 13 Service, U.S.Naval Station, August 1961 to September 1963; continuing on
- 14 worked as a part time employee with the Port authority of Guam,

- 15 Government of Guam where he held the position as Clerk II from
- 16 September 1963 to Jan 1965; and,
- 17 WHEREAS, Luis began his career with the Department of Education,
- 18 Guidance Counselor, Barrigada Junior High, August 1974 to April 1976;
- 19 Head Guidance Counselor, Barrigada Junior High, April 1976 to April 1980;
- 20 Acting School Principal, Barrigada Junior High, September 1977 to February
- 21 1978; School Program Consultant, Personnel Services Division, April 1980
- to September 1980: Personnel Specialist III, October 1980 to October 1982;
- 23 Acting Director of Education, August 1991 to September 1991; Assistant
- 24 Administrator, Personnel Services Division, October 1982 to November
- 25 1992; Acting Director of Education, September 1993 to February 1994;
- 26 Acting Superintendent of Education, December 06, 2002 to December 20,
- 27 2002; Administrator, Personnel Services Division, November 1992 to May
- 28 2006;
- 29 **WHEREAS**, after 19 years of service with the Department of
- 30 Education a School Guidance Counselor, School Assistant Principal, School
- 31 Program Consultant, Personnel Specialist, Assistant Administrator, had
- 32 the sincere desire to contribute more to the education of over 31,000 public
- 33 school students agreed to become the Acting Director of Education and
- 34 then becoming the Director of Education; and,

WHEREAS, Luis has been a contributing member to the community 35 serving as Chairman, Developmental Disabilities Planning Council, 36 Government of Guam, Chairman, Board of Control, Department of 37 38 Vocational Rehabilitation, Government of Guam, Member, Guam Rehabilitation Council, Division of Vocational Rehabilitation, and, 39 Chairman, Dr. Antonio Yamashita Educator Corps (YEC), College of 40 Education, University of Guam, and, 41 WHEREAS, Luis through the years had participated as Workshop 42 Facilitator and Planning Committee Member, Guam Conference of 43 Handicapped Individuals, 1976; Delegate to the Third Annual Conference 44 on Consumer & Practitioners in Rehabilitation in Honolulu, Hawaii, 1977; 45 Delegate to the First White House Conference on Handicapped Individuals 46 by invitation and personal appearance of President Jimmy Carter, 47 Washington D.C., 1977; Headed the Delegation from Guam to the 48 International Conference of the Handicapped, 1981; Panel Presenter 49 Territorial Forum on Disabilities, Washington D.C., 1993; Keynote Speaker, 50 "Blueprint for Survival: A Chamorro Perspective", Second Annual 51 Commission's Institute on Cultural Diversity, Washington D.C., September 52 53 1993, which was edited and featured on the Micronesian Educator, Volume 54 4, 1993, A Journal of Research and Practice on Education in Guam and 55 Micronesia; and
