WHEREAS, the Port currently employs three hundred and sixty eight (368) dedicated and hard-working employees to handle operations as stevedores, cargo checkers, equipment operators, accountants, tariff specialists, administrative staff and managers for the five (5) cargo handling piers, the container yard, two (2) fuel piers, two (2) marinas and a harbor of refuge; and

WHEREAS, the Port annually services more than eight hundred (800) vessels, to include foreign-flagged cargo and fishing vessels; and

WHEREAS, the Port, within the past five (5) years has been awarded more than One Hundred and Thirty Nine Million Dollars (\$139,000,000) in federal grants for various projects, to include the Port modernization projects, security and maritime security upgrades, environmental assessments and repairs at the *Hagåtña* and *Agat* Marinas; and

5	continues to support civic and charitable organizations and events, such as: the American Red
6	Cross, Relay for Life, Continental's Plane Pull and SPPC's "Paddle Against Cancer".

8	to delivering Guam's cargo in a timely and efficient manner, and moving forward with the
9	recommendations outlined in the Master Plan Updates to transform the Port into a modem
10	facility; therefore, be it

12	of the people of Guam, congratulate and commend the dedicated employees, management and
