#### BE IT RESOLVED BY THE COMMITTEE ON RULES OF I MINA TRENTAI 1

#### 2 UNU NA LIHESLATURNAN GUAHAN

- 3 WHEREAS, the Martin Luther King Jr. Day of Service, Monday, January 16,
- 2012, has been designated by Guam law as a means to honor and celebrate Dr. King's life 4
- 5 and legacy by helping our neighbors and communities and by promoting his message of
- 6 equality, social justice, and opportunity for all; and
- 7 WHEREAS, this day, also designated an official Guam holiday, recognizes a true
- 8 leader who continues to serve as a shining example as Guam seeks its appropriate full
- 9 recognition as a member of the American family; and
- WHEREAS, the Martin Luther King Jr. Day of Service is fully supported by the 10
- 11 Governor's Serve Guam! Commission, Guam Department of Labor, The National and
- 12 Community Service (CNCS), Guam Volunteer Center and the three (3) national
- programs: AmeriCorps, AmeriCorps Alums and AmeriCorps\*VISTA; our five (5) 13

1 AmeriCorps Programs: Sanctuary Incorporated, AmeriCorps UOG Success Center,

2 IHOM Life Corp AmeriCorps, Pa'a AmeriCorps, Guma' Mami AmeriCorps; and

WHEREAS, the ceremony marking the Martin Luther King Jr. Day of Service is to be held on January 16, 2012, at 10:00 a.m., at the Agana Shopping Center Court; and

WHEREAS, during the 1950s and '60s, as America's foremost civil rights leader, the Reverend Martin Luther King, Jr. was able to take great strides in achieving voting rights for African-American citizens, who had long been denied this fundamental element of our society; and

WHEREAS, while Reverend King and his followers and supporters were able to win victories in voting rights in many American States, to this day in 2011, the citizens of the District of Columbia and the U.S. Territory of Guam continue to be disenfranchised from national elections; and

WHEREAS, due to our failure to achieve political status on par with most of the United States, American citizens resident in Guam continue to be denied the fundamental right to have a say in selecting our national leaders; and

WHEREAS, although Guam has been treated as U.S. soil since it was taken from the Spanish Crown by force of arms in 1898, its citizens were long subjected to rule by the U.S. military which could be, at the whim of individual commanders, arbitrary and capricious, much as were many local governments in the mainland United States in which persons of color were denied a say by systematic disenfranchisement; and

WHEREAS, it was only after a long history of American military rule, interrupted

2 by Japanese seizure of Guam and harsh treatment at the hands of that country during

3 World War II, that the people of Guam were 'allowed' to elect a Governor and

4 Legislature to represent them; and

WHEREAS, we do not enjoy the ironclad Constitutional civil rights guaranteed to other American citizens; and

WHEREAS, the elements that reflect the honorable legacy of Dr. King and his

8 living teachings are seen in current events that are unfolding on Guam, including the

exercise of civic responsibility by our citizens in response to the present military buildup;

WHEREAS, in the spirit of Reverend King, Guam will redouble its efforts to capture and enjoy the civil rights enjoyed by other Americans. As Reverend King said in 1969, "We shall overcome because the arc of the moral universe is long, but it bends

toward justice;" now, therefore, be it

**RESOLVED,** that the Committee on Rules of *I Mina'Trentai Unu Na Liheslaturan Guåhan*, does hereby, on behalf of *I Liheslaturan Guåhan* and the people of Guam, recognize the Martin Luther King Jr. Day of Service and Guam's parallel pursuit of the continuing legacy of enhanced voter rights that is Reverend King's legacy; and be
