

6 culture, language, heritage and traditions of the Chamorro of Guam and the
7 Marianas; and

3 Felixberto C. Flores; the late Jose Duenas – Vice President and brother of
4 the late Father Jesus Baza Duenas and father of retired U.S. District Court
5 Judge Cristobal C. Duenas; Manuel Ulloa – Secretary, a prominent and a
6 long-time Island educator; the late Adriano Cristobal – Treasurer and
7 grandfather of Superior Court Presiding Judge Alberto C. Lamorena, and
8 the late Vicente Arriola – Librarian/Historian and father of former Speaker
9 Joaquin C. Arriola; the founding fathers of the Organic Act of Guam – the
10 late Baltazar J. Bordallo, the late Eduardo T. Calvo, and the late Francisco
11 B. Leon Guerrero; all Governors of Guam of Chamorro ancestry and to all
12 other members of the YMLG; and
