3        **WHEREAS**, in 1972, JWS Refrigeration & Air Conditioning was  
4        founded as a sole proprietorship. Incorporated in 1978, Founder and Chief  
5        Executive Officer, John W. Scragg, embarked on a company mission to  
6        become an industry leader in this area of the Pacific, specifically, Guam; and

7        **WHEREAS**, JWS stands out as a leader in introducing HVAC  
8        technology to Guam and the region. Being the first company to introduce  
9        heat recovery, inverter compressors, 24.5 SEER rating Air conditioning  
10       units and Oil less compressors for commercial application. JWS is the first

1 company on island to promote energy efficient units and discontinue  
2 promoting NON- energy / ozone depleting equipment; and

3 **WHEREAS**, through the past 40 years JWS has evolved into a full  
4 service and maintenance company for air conditioning, refrigeration, and  
5 commercial kitchen equipment. Other departments include Mechanical  
6 contracting, Engineering, wholesale, sales in air conditioning, refrigeration,  
7 commercial kitchen equipment and special applications; and

8 **WHEREAS**, JWS has grown to become the leading supplier of  
9 commercial, and residential refrigerant and air conditioning, servicing  
10 Guam, Palau and the Federated States of Micronesia. JWS has a branch  
11 office in Saipan that services the Commonwealth of the Northern Mariana  
12 islands; and

13 **WHEREAS**, for over three decades JWS has supported the local  
14 apprenticeship programs, Guam Community College and the GCA Trades  
15 Academy with the teaching of technical skills. CEO John Scragg  
16 participated in the interception of the apprenticeship program at GCC by  
17 aiding in creating the curriculum for the HVAC course many years ago; and

18 **WHEREAS**, for the past 40 years, JWS has still retained one owner  
19 and shows its commitment to Guam by hiring and training 50 full-time local  
20 employees; now, therefore, be it
