RELATIVE TO PROMOTING THE KNOWLEDGE AND **CHILD AWARENESS** OF ABUSE AND NEGLECT, ESPECIALLY CHILD SEXUAL ASSAULT ON GUAM, AND TO BRING ATTENTION TO THE FRONT LINE STAFF ALL OF THE GOVERNMENT OF GUAM AGENCIES AND PRIVATE NONPROFIT ORGANIZATIONS WHO WORK TIRELESSLY TO PREVENT AND TREAT VICTIMS OF CHILD ABUSE TO MAKE GUAM SAFER AND FOR THEIR CONTINUED COMMITMENT TO REDUCING THE INCIDENCE OF CHILD ABUSE ON GUAM.

BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA*'TRENT AI UNU NA LIHESLATURAN GUÅHAN:

WHEREAS, Child abuse and neglect, including child sexual assault are social problems that contribute to significant personal challenges for victims and to the decay of our families and communities as strong, viable units; and

WHEREAS, the reports of Child Abuse and Neglect cases on Guam were
1,897 affecting 2,512 children, an increase from 2011 of nearly 40%; and

WHEREAS, all other reports of referrals to the Department of Public Health and Social Services' Child Protective Services was over 3,000 signaling an urgent call for help in the protection of Guam's children, youth and families; and

WHEREAS, the incidences of child abuse and neglect often result in lifelong challenges to the victims thwarting their personal development and abilities to be productive citizens; and

WHEREAS, victims of child abuse and neglect are more likely to be at risk for depression and other mental illness, for substance abuse, and to struggle to sustain educational and work activities and maintain healthy interpersonal relationships; and

WHEREAS, the hundreds of victims each year who are cases of substantiated abuse impact thousands more individuals who they live and work with and who are their family, friends and neighbors; and

WHEREAS, the community response to the tragedy of child abuse and neglect rests with our families, communities and all of our agencies both private and governmental; and

WHEREAS, there are a core group of individuals in these agencies who are on the front lines ready and willing to assist 24 hours a day, 7 days a week including holidays, to protect and support victims of child abuse and neglect; and

WHEREAS, these individuals and agencies should be acknowledged for their selfless dedication and commitment to our children, youth and families; and now therefore be it

RESOLVED, that *I Liheslaturan Guåhan* and the people of Guam, support the Department of Mental Health and Substance Abuse; the Department of Public Health and Social Services; the Department of Youth Affairs; the Guam Police Department; the Office of the Attorney General; the Superior Court of Guam; Sanctuary, Incorporated; Catholic Social Services; Victims Advocates Reaching Out (VARO); and the Guam Coalition Against Sexual Assault and Family Violence's (GCASAFV) efforts to increase the awareness and the strategies to prevent child abuse and neglect on Guam and to continuously work in
