1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF**

2    ***I MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS**, Mr. Joeseph Anthony Villagomez was born on January 13,  
4 1990 to Mr. Jesse Anthony Villagomez and Mrs. Teresita Leon Guerrero  
5 Villagomez; and

6           **WHEREAS**, Joseph attended Bishop Baumgartner Memorial Catholic  
7 School from kindergarten to eighth grade where he was inducted into the National  
8 Junior Honor Society and elected President to the Student Council; and

9           **WHEREAS**, he later attended Father Duenas Memorial School and  
10 graduated with honors in 2008; and

11          **WHEREAS**, while attending FDMS, Joseph was heavily involved with the  
12 Phoenix Company Naval Junior Reserve Officer Training Corps. He reached  
13 Commanding Officer position as Lieutenant Commander, was awarded the

1 Meritorious Ribbon, brought the unit into compliance to attain the Distinguished  
2 Unit status, led the Color Guard Team to first place at the annual Army Field Meet  
3 event two consecutive years in a row and received numerous awards for exemplary  
4 performance and leadership; and

5 **WHEREAS**, Joseph began his studies at the University of Guam in the fall  
6 of 2008 and graduated in three and half years as Magna Cum Laude with a  
7 bachelor's degree in Criminal Justice in December 2011 and began his graduate  
8 studies towards a Master of Public Administration degree at the University of  
9 Guam in January 2012; and

10 **WHEREAS**, during his undergraduate years, Joseph was the president of  
11 the Lamda Psi Chapter of Alpha Phi Sigma, the National Criminal Justice Honor  
12 Society from Fall 2009 to Fall 2011 and the Secretary of the Public Administration  
13 and Legal Studies Society (PALS) from Spring 2011 to Fall 2011; and

14 **WHEREAS**, Joseph has been involved in the community as an altar server  
15 at the Cathedral Basilica for over thirteen (13) years, the conductor of the Hearts of  
16 Family Choir at the Immaculate Heart of Mary Parish for over six (6) years where  
17 he also serves as the chairperson for music ministry. He has also given his time to  
18 feed the hungry at Kamalen Karidat and at Manamko' night at the Toto Parish; and

19 **WHEREAS**, Mr. Villagomez was appointed to serve the remainder of the  
20 student regent's term to expire May 7, 2012 through an election by the 50<sup>th</sup> Student  
21 Government Association on February 24, 2011; and

22 **WHEREAS**, during his term as student regent, he served as a member of the  
23 Academic Personnel and Tenure Committee and the Student Affairs, Scholarship,  
24 Alumni Relations, and Honorary Degree Committee; and

25 **WHEREAS**, Joseph, as the student regent of the University of Guam  
26 demonstrated a high level of commitment to representing the student voice on the  
27 Board of Regents by addressing issues of concerns and actively participating in

1 UOG community and Board of Regents meetings, activities and events; and now,  
2 therefore be it

3 **RESOLVED**, the Committee on Rules of *I Mina'Trentai Una Na I*  
4 *Liheslaturan Guåhan*, does hereby, on behalf of *I Liheslaturan Guåhan* and the  
5 people of Guam, recognize and commend Joseph Leon Guerrero Villagomez on  
6 the completion of his term as student member of the Board of Regents of the  
7 University of Guam and extend a sincere *Un Dångkolo Na Si Yu'os Ma'åse* for his  
8 service and dedication to the community and the University of Guam; and be it
