for their services to assist the Guam Chinese School.**

**BE IT RESOLVED BY THE COMMITTEE ON RULES OF
I MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN:**

WHEREAS, the Desheng Youth String Orchestra was established by Kaohsiung Desheng Presbyterian Church in the spring of 2001 and was headed by Senior Pastor Chong-Ming-Hu; and

WHEREAS, the orchestra recruits new members, rehearses, and hosts concerts on a regular basis and ministers during Sunday services; and

WHEREAS, the repertoire of the Desheng Youth String Orchestra includes sacred music, classical music, contemporary music and folk music; and

WHEREAS, the orchestra is made up of both church members and members of the local community. The group not only focuses on music education, but on the importance of building personal character as well; and

WHEREAS, the Desheng Youth String Orchestra expanded into a full orchestra in 2006 and was invited to Japan in July of the same year; and

WHEREAS, the group uses the this concert tour as an opportunity for cultural exchange when visiting other countries; and

2 amateur performing arts group and was renamed as Desheng Music Ensemble; and

3 **WHEREAS**, the orchestra provides many opportunities for young musicians
4 and allows them to help the less fortunate through their musical performance; and

5 **WHEREAS**, the musical group successfully raised funds for many charities
6 and contributed to the construction of a new gym for the Singapore Presbyterian
7 High School during their 2010 Tour; and

8 **WHEREAS**, the visiting music group from Taiwan has come to Guam to
9 help raise funds for the construction of the multi-purpose facility for the Guam
10 Chinese School; and now, therefore be it

11 **RESOLVED**, the Committee on Rules of *I Mina'Trentai Una Na I*
12 *Liheslaturan Guåhan*, does hereby, on behalf of *I Liheslaturan Guåhan* and the
13 people of Guam, recognize and commend and extend a sincere *Un Dangkolo Na Si*
14 *Yu'os Ma'åse* for; and be it further
